State rule requires any transport which can be anticipated is to be scheduled between 7:00 AM and 6:00 PM Monday through Friday (except major holidays) by calling the appropriate Medicaid Brokerage for prior authorization; CERC for Central Oregon residents. Unanticipated rides, based on urgent need only, can be scheduled directly with a transport provider when needed After Hours and CERC is not open to pre-authorize and schedule.

State rule requires the lowest cost means of transportation available, and appropriate based on the patients physical/medical needs, be used or they will reject payment as an ineligible ride.

After Hours OHP Providers for AMBULATORY Riders

Can walk and enter/exit the vehicle on their own, OR, can enter/exit vehicle with assistance from an attending care giver – drivers can offer a hand or arm to assist a rider in and out of the vehicle, but riders are to "transfer" without help of the driver.
